Official Rules and Regulations for WBC 2015 Chicago Consular Corps Gala Raffle

World Business Chicago ("WBC"), an Illinois not-for-profit corporation with a tax-exempt status under section 501(c)(3) of the Internal Revenue Code, with offices at 177 N. State Street, Chicago, IL 60601 is conducting a raffle ("Raffle") with prizes drawn at its 2015 Chicago Consular Corps Gala (the "Gala") to raise funds for ongoing charitable purposes. The Raffle is a random drawing raffle to occur at the Gala to be held on or about Tuesday, December 15, 2015 at the Hilton Chicago, 720 South Michigan Avenue, Chicago, Illinois (the "Drawing").

The 2015 Raffle Official Rules and Regulations (the "Official Rules") are set forth below. By purchasing a Raffle ticket (a "Ticket"), the purchaser acknowledges that he or she is aware of, and agrees to be bound by, these Official Rules and WBC's interpretation of any such Official Rules. WBC shall be responsible for interpreting and applying the Official Rules. WBC's interpretation and application of such rules shall be final.

Eligibility: Any individual who is 21 years of age or older at the time of the purchase of the Ticket is eligible to enter the Raffle. All federal, state, and local laws and regulations apply. The Raffle is void where prohibited by law.

How to Enter: Tickets are \$100.00 each. To enter, eligible entrants much purchase one or more raffle tickets for the Raffle anytime between November 20, 2015 and December 15, 2015, prior to the Drawing and while supplies last (the "Entry Period.").

Only one (1) eligible person may be entered in the Raffle per Ticket sold. If the name of more than one (1) person is provided on a Ticket entry form and that Ticket is selected as a winning ticket, then the person named first will be deemed as the holder of record of that Ticket and declared the winner. The division of any prize among a group of persons purchasing a Ticket in common shall be to the sole responsibility of the person named as the holder of record of that Ticket be selected as a winner. WBC is not responsible for resolving any disputes that may arise from different individuals listed on a winning Ticket.

Tickets may be purchased: during the Entry Period at the Gala or online at www.chicagosistercities.com.

Tickets will not be sold after December 15, 2015. Tickets may sell out before that time. An individual can purchase as many Tickets as he or she may wish, subject to availability.

Visit www.chicagosistercities.com and click on "purchase tickets." Follow the instructions to complete the order form and submit payment.

No refunds will be made except under the following circumstances: any ticket order with payment received after (1) 2000 Tickets have been sold, or (2) December 15, 2015, after the Drawing will be returned. No other refunds are available except in the exclusive discretion of WBC.

Selection of Winners: Winner will be randomly selected by WBC or WBC's representative at the Drawing. Winners need not be present at the Drawing to win. Winners will be selected at random. A finalized prize list and order will be displayed at the Gala. Raffle tickets will be pulled the night of the event, and prizes will be awarded based on the predefined order.

WBC will attempt to notify winners based on contact information provided by each winner to WBC on the entry at the time of purchase. Entrants are solely responsible for providing WBC with accurate and updated information. Winners must acknowledge acceptance of their prize to WBC within seventy-two (72) hours of WBC's attempted notification, and may be required to complete and return within such time period an affidavit of eligibility and a liability and publicity release. If, for any reason, a potential winner is ineligible, unable or unwilling to accept the prize then the potential winner may be disqualified and forfeit the prize and an alternate winner may be selected by WBC in WBC's sole discretion at random from among all eligible non-winning entries received; in such event, the disqualified potential winner will not be awarded an alternate prize.

If a selected winner is unable to be contacted or located after a period of four (4) months from the draw date of the applicable raffle drawing, the prize or its cash equivalent will be deemed to have been donated to WBC.

A list of winners will be posted on the Raffle website one week of the applicable drawing.

Winning Odds: The odds of winning a prize will depend on the number of tickets sold. A maximum of 2000 tickets will be sold for this Raffle.

Non-Deductibility of Ticket Purchase: The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently, the purchase of a Ticket does not qualify as a deductible charitable contribution.

Terms and Conditions: The Raffle is subject to these Official Rules. These Official Rules cannot be changed by any oral statement made by any employee, consultant or agent acting on behalf of WBC. By entering WBC Raffle, entrants accept and agree: (1) to be bound by these Official Rules and the decisions of WBC which shall be final and binding; (2) waive any right to claim ambiguity in the Raffle or these Official Rules; and (3) that WBC may use the entrant's name, photograph, likeness, statements, biographical information, voice and city and state address for promotional or advertising purposes in connection with the Raffle on a worldwide basis and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation, except where prohibited by law.

BY ENTERING WBCS RAFFLE, EACH ENTRANT RELEASES WBC, ITS DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS FROM ANY AND ALL LIABILITY FOR INJURIES, LOSSES OR DAMAGES OF ANY KIND (INCLUDING, WITHOUT LIMITATION, ATTORNEY'S FEES) CAUSED BY PARTICIPATING IN THE RAFFLE OR WINNING ANY PRIZE OR RESULTING FROM ACCEPTANCE, POSSESSION, USE OR MISUSE OF ANY PRIZE, AND EACH WINNER AGREES TO INDEMNIFY AND HOLD WBC HARMLESS FROM ANY AND ALL LOSSES, DAMAGES, RIGHTS, CLAIMS AND ACTIONS OF ANY KIND ARISING FROM, IN CONNECTION WITH, OR AS A RESULT OF PARTICIPATING IN THE RAFFLE OR THE WINNER'S ACCEPTANCE OR USE OF ANY PRIZE.

A RAFFLE ENTRANT'S SOLE AND EXCLUSIVE REMEDY FOR ANY CLAIM AGAINST WBC ARISING OUT OF THE SALE OF TICKETS OR THE CONDUCT OF THE RAFFLE SHALL BE LIMITED TO THE RETURN OF THE PURCHASE PRICE PAID FOR HIS OR HER TICKET(S). IN NO EVENT SHALL WBC, ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS OR REPRESENTATIVES BE LIABLE TO ANY PARTY FOR ANY LOSS OR INJURIES TO EARNINGS, PROFITS OR GOODWILL, OR FOR ANY INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY PERSON OR ENTITY WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE RAFFLE OR THESE OFFICIAL RULES SHALL BE SETTLED BY BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION (PURSUANT TO ITS EXPEDITED PROCEDURES) UNDER ITS COMMERCIAL ARBITRATION RULES AND CONDUCTED IN CHICAGO, ILLINOIS, AND JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED IN ANY COURT HAVING JURISDICTION THEREOF.

Cancellation/Termination of Raffle: By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that WBC has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy shall be to receive a refund of the full price paid by such participant for each Ticket purchased, without interest.
